For 40 years, FSS' Meals On Wheels program has been delivering a difference to seniors in Fayette County. With the help of our community, we can ensure that no senior in our community suffers from inadequate nutrition and hunger.

Each year, Fayette Senior Services, Inc., a non-profit 501.c.3 organization, delivers more than 56,000 meals to home-bound older adults. Meals On Wheels are delivered by a team of dedicated volunteers who deliver much more than a meal. Quite often, our volunteers provide the only social contact a home-bound senior may receive during the day. Each visit assures the well-being of the Meals on Wheels recipient as well as provides social contact so they can continue to live independently in the comfort of their own home. Many of our clients often share the impact it has on their lives and their gratitude for the service!

Project Love provides for holiday and some weekend meals throughout the year that our yearly budget does not cover. Individuals, families, businesses and churches can purchase a holiday meal for as little as \$5. Each meal pack includes a variety of meals that meet the Recommended Dietary Allowance (RDA). We also offer meals that meet special dietary restrictions. Meal packs are oven/microwave-ready and delivered frozen so they may be used at a time best suited for each recipient.
